BRIDAL CONTRACT

Thank you for your interest in our Wedding Services. Please read this document very carefully before signing our contract.

TRAVEL

We are happy to provide your services in our salon. However, if you would prefer us to travel to your venue, our travel fees are complimentary up to 20 miles, \$50/service provider to travel 21-30 miles and \$100/service provider to travel 31-50+ miles. Hotel accommodations (for travel over two hours) will be billed in addition. Maximum of two people per room.

PRIVATE SALON RESERVATIONS & REFRESHMENTS

The morning of your wedding, we will provide you with complimentary refreshments (coffee, tea, water, pastries); however, if you would like Mimosa's or champagne, please let us know in advance. If you would prefer to reserve the entire salon the day of your wedding, we will provide you lunch and close to regular customers for an additional \$500.00. Salon reservations must be requested a minimum of 3 months to close for your party.

PACKAGES & TRIALS

Most of our bridal packages include and are limited to one "practice session" only which are described as preparation makeup application with strip lashes (unless you booked lash extensions) and preparation bridal style. Additional practice sessions are available for a la carte pricing. Our bridal packages require a reservation prior to the appointment date.. When coming in for your pretrial appointments you will need the following items with you... your headpiece or veil (if you have one), and a picture of the hairstyle/makeup you are trying to achieve or something similar. If after you have your pretrial appointment and still do not feel accomplished in your desired result you may book another appointment with your stylist, but note that the next appointment will be at a regular rate as was your first pretrial appointments.

CANCELLATIONS

75% of the deposit is refundable for cancellations, as long as the cancellations are submitted in writing/email at least 90 days prior to the bride's first reservation date. 100% of the deposit is **non-refundable** for cancellations that are made within 90 days of the bride's reservation or no shows the day of. Finally, please note that any/all services performed within Avenue Allure Salon, Spa & Boutique must be performed by a Avenue Allure professional only. We are unable to allow participants to do their own services within our establishment.

Scheduling

Groups and wedding parties should be scheduled four to six months in advance and nine months in advance for prime bridal season dates (May-October). While we do our best to have all appointments run on time, there will be times when a preceding client treatment may exceed its scheduled duration and put us behind schedule. We will make every effort to keep you from waiting.

Any appointments booked before/after normal salon hours (9-6 Tue-Fri & 9am-1pm Saturday) will have an extra additional fee of \$25.00 added to each service requested. It is imperative that arrangements are confirmed at least 14 days prior to the wedding day. Our salon services are often booked far in advance and changes within 14 days may or may not be possible, but we will do everything possible to accommodate any changes as long as there is time, and availability with our stylists.

THE BIG DAY

Please tell all members of your bridal party to arrive 15 minutes prior to all of their scheduled appointments. When coming in to the salon for a scheduled Up-Do PLEASE come in with clean (hair washing is NOT recommended), and completely dried hair *We recommend all members of the bridal party wear a button down shirt at time appointments.

Anyone who arrives with wet hair will be charged an additional \$20 fee and possible adjusted appointment time slot to accommodate drying time. Anyone in your party who books as a Blow Dry and decides to switch to an up do or has an appointment for an up-do and changes to a blow dry will be charged accordingly (given there is appropriate time for service change).

We understand that there are times when you may be running late. Please give us a call if you will be more than 10 minutes late so we can arrange the schedule for your Service and the Services for those scheduled after your appointment. Your appointment time will run according to the allotted time which means we cannot make another appointment run late if you are not on time. Full Price of the service will be charged, Regardless of the time spent with the stylist.

PAYMENTS

To reserve your bridal dates, we collect a deposit of 1/2 the entire payment for all bridal services including applicable travel fees. The remaining balance is due 3 days before your actual wedding date. We reserve all appointments with a credit card.

BRIDAL PARTY

Please discuss times, and directions with your bridal party to ensure that everyone is running on the same timely manner.

Once you have agreed and signed the above documents, we ask that you send, and go over the policies and appointment times for each and every person in your bridal party. It is imperative that everyone in your bridal party is aware of certain procedures and protocols to ensure that everyone achieves their desired look and feel the day of the wedding, and MOST IMPORTANTLY that everyone has a Great Experience as well as a fun time.

If you are requiring your bridal party to pay for their own services, we ask that you collect the fee from them and pay us all in one transaction, 3 days prior to your wedding. This makes the day go a lot more smoother as people are leaving and heading to the venue. Any extra fees incurred during your appointment will be discussed with your bridal party and charged before they leave.
